The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to widows of riots/terrorist violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No.8/259/90-RR-2/10778, dated 10-5-1990 and subsequent amendments made vide Notification No.8/259/90-RR-2/6211, dated 26-9-1990; No.8/259/90-RR/8109, dated 11.7.1991; No.8/259/90-RR-2/504, dated 22-1-1992; No.8/259/90-RR-II/936 dated 30-9-1992; No.6/137/97-RR-2/13762 dated 25-7-94; No.6/130/94-RR-/20150 dated 30-11-1994; No.6/137/92-RR-2/5606 dated 31-3-1995; No.8/67/94-RR-2/2930 dated 16-2-1996; No.10/23/96-RR-2/15999, dated 26-11-1996; 6/221/RR-2/17490 dated 31-12-96, and letter No.8/314/96-RR-II/9795 dated 20-6-1997.

- i) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/TERRORIST VIOLENCE (1ST AMENDMENT) RULES, 1998.
- ii) These rules shall be applicable throughout the State of Punjab.

RATE OF SUBSISTENCE ALLOWANCE

The rate of subsistence allowance has been enhanced from Rs.1500/- per month to Rs.2500/- per month, for the Sikh migrant widows of innocent civilians killed in November, 1984 riots during the period from 31-10-1984 to 7-11-1984 as well as for those sikh migrants who have suffered 100 percent permanent disability in the said riots.

EFFECT

The payment shall be effective from 1-8-1998.

The expenditure involved is debitable to the Head "2235-Social Security and Welfare-60-Other Social Security and Welfare Programme-110-Other Insurance Scheme-01-Subsistence Allowance to victims of November, 1984 riots.

This Notification issues with the concurrence of the Department of Finance vide their I.D. No.8/6/90-3FE6/2115 dated 25-8-1998 and 8-6-90-3FE6/2802 dated 17-11-98.






