No.6/216/94-RR-2/17551 The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to widows of riots/terrorists violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No.8/259/90-RR-2/10778, dated 10.5.1990 and subsequently amended vide Notification No.8/255/90-RR-2/3211, dated 26.9.1990, No.8/259/90-RR-2/8109, dated 11.7.1991, No.8/259/90-RR-2/504, dated 22-1-1992, No.8/259/90-RR-2/936, dated 30.9.1992, No.6/137/92-RR-2/13753, dated 25.7.1994 and No.6/130/94-RR2/20150, dated 30.11.94 :-

- i) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/TERRORIST VIOLENCE (1st AMENDMENT) RULES, 1995.)
- ii) These Rules shall be applicable throughout the State of Punjab.

RATE OF SUBSISTENCE ALLOWANCE

The rate of subsistence allowance has been enhanced from Rs.1000/- per month to Rs.1500/- per month for the widows of civilians killed in November, 1984 riots (during the period from 31.10.1984 to 7.11.1984). The Dependent parents (both or mother alone or father alone, if alive) of only son or all sons (married or un-married) killed by the terrorists shall also be entitled to Subsistence allowance at the rate of Rs.1500/- per month. The subsistence allowance at the rate of Rs.300/- per month shall be paid to both the parents or mother alone or father alone, if their any son is alive.

EFFECT

The payment shall be effective from 1.4.1995.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer(C) concerned shall be the sanctioning authority under this scheme. He/She shall pass orders in each case, after due verification.

2. The expenditure involved is debitable to the Head "2235-Social Security and Welfare-60-Other Social Security and Welfare Programme-110-Other Insurance Scheme-01-Subsistence Allowance to victims of terrorist violence in Punjab".
