

NOTIFICATION

Dated, the 26th November, 1996.

No.10/23/96-RR-2/15999. The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to widows of riots/terrorist violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No.8/259/90-RR-2/10778, dated 10.5.1990 and subsequent amendments made vide Notification No.8/259/90-RR-2/6211, dated 26.9.1990; No.8/259/90-RR-2/8109, dated 11.7.1991; No.8/259/90-RR-2/504, dated 22.1.1992; No.8/259/90-RR-II/936 dated 30-9-1992; No.6/137/97-RR-2/13762 dated 25-7-94; No.6/130/94-RR2/2150 dated 30-11-1994; No.6/137/92-RR-2/5606 dated 31-3-1995 and No.6/67/94-RR-2/2930 dated 16-2-1996:-

- i) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/TERRORIST VIOLENCE (2nd AMENDMENT) RULES, 1996.
- ii) These Rules shall be applicable throughout the State of Punjab.

RATE OF SUBSISTENCE ALLOWANCE

The rate of subsistence allowance has been enhanced from Rs.1000/- per month to Rs.1500/- per month for those who have sustained permanent disability exceeding 70 per cent in terrorists violence, if the victim is unable to work for the livelihood.

EFFECT

The payment shall be effective from 1-4-1996.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer(C) concerned shall be the sanctioning authority under this scheme. He/She shall pass orders in each case, after due verification.

It shall be obligatory to obtain considered medical opinion from the medical officer who shall clearly indicate the nature and extent of disability and whether the same is of permanent nature or not. The payment of subsistence allowance shall be subject to certification/verification that the victim is unable to work for the livelihood.

2. The expenditure involved is debitable to the Head "2235-Social Security and Welfare-60-Other Social Security and Welfare Programme-110-Other Insurance Scheme-02-Subsistence Allowance to victims of terrorist violence in Punjab".

3. This Notification issues with the concurrence of the Department of Finance vide their I.D. No.8/5/96-3FEG/2212 dated 9.8.1996.
