NOTIFICATION

Dated, the 30 November 1994.

No. 6/130/94-RR-2/ 20150 The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to Widows of Riots, /Terrorist Violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No. 8/259/90-RR-2/10778, dated 10.5.1990 and subsequent amendments made vide Notification No. 8/259/90-RR-2/6211, dated 26.9.1990; No. 8/259/90-RR-2/8199, dated 11.7.1991; No. 8/259/90-RR-2/504, dated 22.1.1992; No. 8/259/90-RR-2/936, dated 30.9.1992 and No. 6/137/92-RR-2/13763, dated 25.7.1994:-

- i) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/TERRORIST VIOLENCE (2nd AMENDMENT) RULES, 1994.
- ii) These Rules shall be applicable throughout the State of Punjab.

ELIGIBILITY

New clause (xviii) is added after the clause (xvii) below the sub-rule (i) and (ii) of Rule 3 of eligibility, namely:-

- xviii) "Minor children of innocent civilian(s) killed in terrorists violence or by security forces, in action or otherwise, if their widowed mother deserts them on her remarriage or otherwise".
(The widow will not be eligible for any amount of subsistence allowance, if and when she deserts her children).

Provided the subsistence allowance will stop as and when the beneficiary(s) gets employed under priority category No. 1.

RATE OF SUBSISTENCE ALLOWANCE

The rate of Subsistence Allowance will be equal to the subsistence allowance admissible to orphans (i.e. Rs.1000/- per month) in terms of the State Government instructions issued from time to time. If the number of children exceeds one, the subsistence allowance shall be paid in equal shares.

EFFECT

The payment shall be effective from the date of issue of this Notification.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer (C) concerned shall be the sanctioning authority under this scheme. He/she shall pass orders in each case after verification.

2. The expenditure involved is debitable to the Head "2235-Social Security and Welfare-60-Other Social Security and Welfare Programme-110-Other Insurance Scheme-02-Subsistence Allowance to victims of terrorist violence in Punjab".
