NOTIFICATION

No. 6/67/94-RR-2/ 2930 The Governor of Punjab is pleased to make the following amendment in the subsistence allowance to widows of Riots/terrorist violence Rules, 1990 published in the Punjab Government Gazette dated 10th May, 1990-vide Punjab Government Notification No. 8/259/90-RR-2/10778, dated 10th May, 1990 and subsequent amendments made vide Notification No. 8/259/90-RR-2/6211, dated 26th September, 1990; No. 8/259/90-RR-2/8109, dated 11th July, 1991. No. 8/259/90-RR-2/504, dated 25th July, 1994, No. 6/137/92-RR-2/20150 dated 30th November, 1990, No. 6/137/92-RR-2/5606, dated 31st March, 1995, and 6/216/94-RR-2/17551, dated 11th December, 1995.

- (1) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/TERRORIST VIOLENCE (1ST AMENDMENT) RULES, 1996.
- (ii) These Rules shall be applicable throughout the State of Punjab.

Proviso to Sub-para of Sub-Rule (i) and (ii) of Rule of Eligibility is substituted to the extent that the widows of terrorist victims killed in terrorist violence in the State of Punjab shall be paid the subsistence allowance at the rate of Rs. 1500/- per month on their desertion by their nominees sons and daughters after getting employment under priority category No. 1. This allowance shall be paid subject to the following conditions :-

- a) This benefit is to be given only to the dependents of persons killed in terrorist violence.

- b) Status of widow as one deserted by her sons/ daughter should be verified by an officer of the rank of Sub-Divisional Officer (C) in which the beneficiary resides.

EFFECT

The payment shall be effective from the date of this notification. No arrear will be paid.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer (C) concerned shall be the sanctioning authority under this Scheme. He/ she shall pass orders in each case, after due verification.

2. The expenditure involved is debitable to the Head "2235- Social Security and Welfare- 60- Other Social Security and Welfare Programm- 110- Other Insurance Scheme -02- Subsistence Allowance to victims of terrorists violence in Punjab."
